How to Fix America's Refugee / Immigration system

First - Immigration into the U.S. is a privilege, NOT a right:

Every country has restrictions on immigration and controls their borders to prevent illegal immigration. Any country that will not control their borders is no longer a sovereign nation. Immigrants who come here legally deserve our respect and support. Illegals don't. All immigrants to America must be vetted for disease and criminal history. Immigrants can enter the U.S. **only if we allow it.**

It has been pointed out that there was illegal immigration earlier in our country's history in an attempt to justify today's illegals. This is not a valid comparison because: 1) In the past, the US was under-populated so it didn't matter. Today we are over-populated. 2) Those immigrants loved their adopted country - the USA!

Some politicians (Democrats) claim that wanting to deport illegal immigrants is an attack on Hispanics. NOT TRUE. All this rhetoric is a deliberate lie intended to arouse ethnic hatred and social unrest. **Vetting immigrants and** deporting illegals is not new. Since most terrorist attacks around the world are by Muslims, we have a moral obligation to examine Muslim immigrants more closely.

Second - How many immigrants/refugees should we let in?

Immigration into America MUST be limited to what our economy can absorb and doesn't displace American workers. This is really the deciding factor on implementing a rational immigration policy. America must be kept American. . . Those who do not want to be partakers of the American spirit ought not to settle in America."(2)

Sadly, we now have a class of Immigrants who are American in name only. These immigrants, both legal and illegal are unamerican in their hearts and anti-American in their conduct. - D) Minors brought to the US by parents who were illegal did not knowingly do anything wrong. Yet protecting 'Dreamers' in the DACA program will just encourage more illegal immigration and disrespect for US law.

in the year of our Lord one thousand eight hundred and eighty Wine
Present, The Honorable THOS. J. MORRIS, Judge of Maryland District.

Among other were the following proceedings, to wit:
Be it Remembered, That on the thickeell day of Toptouber in the year
aforesaid deab a native of Germany
and at present residing in the City of Saltimore appeared in open
Court here, and applied to be admitted to become a Citizen of the United States. And it appearing
to the satisfaction of the Court here that the said forces
had declared on oath, taken in the Court of Common Pleas for
Dalling City
on the 15th day of March in the year of
our Lord one thousand eight hundred and Cifety leves two years at least before his admis-
sion, that it was bona fide his intention to become a citizen of the United States. And it also appear-
ing to the satisfaction of the Court here, upon the testimony of foliate Carl
that the said force of the United States five years at least and one
to reside within the limits and under the jurisdiction of the United States five years at least, and one year at least immediately preceding this application within the State of Maryland; that during the
said term of five years he hath conducted himself as a man of good moral character, attached to the
principles of the Constitution of the Inited States, and well disposed to the good order and happi-
ness of the same. And the said facub having
declared on oath, taken in open Court here, that he will support the Constitution of the United States,
and that he doth absolutely and entirely renounce, and abjure all allegiance and fidelity to every foreign Prince; Potentate, State and Sovereignty whatever, and particularly all allegiance and fidelity
to the Cheferry of Germany
The Court here thereupon admits the said Mebb
to become a ctizen of the United States.
In Testimony That the aforegoing is a true copy, taken from the Record and Proceedings of the District Court aforesaid, I hereunto subscribe
my name and affix the Seal of the said District Court to this
Certificate of Naturalization, this gear of our Lord one thousand
eight hundred and eighty Deligee
Jus M, Chu
Clerk of the District Court.
